- 1. Call to order 7:01 pm
- 2. Old Business
 - a. Approval of the minutes
 - i. 3/21/23 name errors corrected. Motion to approve by CS seconded by LS Unanimously approved. NB abstain due to absence
 - b. Planning for the Future of your Farmland
 - i. Positive feedback on Feedback form
 - 1. SM to send thank you card to Tonia at Bounti Fare
 - c. Right to Farm updates
 - i. No updates yet from NB about wetlands guidelines
 - ii. LS update from Northampton Right to Farm
 - 1. Does not have cannabis provisions because it was illegal to grow when it was written.
 - 2. Cannabis and hemp growing is heavily regulated but not by the State or local Ag Commissions.
 - LS printed articles from the Hampshire Gazette regarding cannabis regulations in other Western Mass Towns.
 - NB suggests that cannabis is not yet under the purview of the Ag Commission as it stands now. But we should stay apprised of cannabis growing laws.
 - 5. CS mentions that there was an article in the Berkshire Eagle last week about farmers petitioning APR to allow hemp to be grown.

- Carleigh asks about a pop up market on her road near the glen at Chenail Crofts. Carleigh to connect to Events committee. Ag committee could help tell people about her event and find vendors for her.
- ii. Gather historic information about Adams farms
 - 1. NB says that Cheshire created a farming history book. We could start collecting data for a similar project.
 - 2. Joe suggests connecting to Eugene M at the Adams Historical Society as a point person.
- iii. Event planning for younger generations in Adams? What can we offer new farmers.
 - NB suggests that succession planning would be helpful. MB recommends the succession planning workshop through Land for Good.
 - 2. NB suggests dividing the grant list and adding more descriptions to help people figure out if they qualify.
 - 3. Carleigh says that Jessica Camp from MDAR has offered to host a more in depth "beginning farmer resource" workshop.
 - 4. MB suggests that Berkshire Ag ventures, Farm Credit East, and NRCS, and FSA could also present at the workshop.
