• Sunglasses for Kids (plus educational materials from DPH) Dr. Rhoads said that the sunglasses have arrived and will be available at the Health Dept Booth at Town events.

#### **New Business:**

   Dr. Rhoads noted that there will be useful public health education materials available at the Board of Health booth at Town events for distribution. Dr. Rhoads may explore placing the materials in Town Hall as well.
- Nominations for public service during the pandemic (list to be presented at BCBOHA spring dinner)

  Dr. Rhoads said that there is usually 2 meetings annually and were suspended due to Covid. There were some remote meetings. There will be an in-person meeting in mid-June. The topic will be regarding After Action Report on Covid. The association had performed surveys and some of the findings were that there was some criticism of emergency plans available at PTH state level, but were not utilized, local Boards of Health were ignored. Fortunately, in Berkshire County, we have a strong collaboration amongst the municipalities and there is still room for improvement. We would like to have a list of local individuals that provided exceptional service above and beyond during the pandemic. Some of the names that contributed were Jay Green, Christine and Pete Hoyt, Erica Girgenti. Dr. Hoyt will compile a list and send to Dr. Rhoads.
