CALL TO ORDER: On the above date, the Board of Selectmen held a meeting at 7:00 PM at the Adams Town Hall. Chair John Duval opened the meeting. Gerry Garner stated that Topia Inn, 10 Pleasant St., has failed its inspection but has an appointment for Monday and hoping it will be resolved.

Motion from Vice-Chair Hoyt to Table the approval of the Lodging License for the Mount Royal Inn, 99 Howland Avenue. Motion is seconded by Member Blanchard. Vice-chair Hoyt asked that a representative of the Mount Royal Inn be present. Member Nowak asked if someone can speak to the issues that are happening there.

Gerry Garner spoke to the violations that are happening at the Mount Royal Inn. There are individuals living there for 6 months or more. The license that the Mount Royal Inn currently has allows them to have people there for no longer than 30 days. They do not have the ability to hold folks there for 6 months. They don't have the appropriate logs of who is there, how long they have been there for, and they do not have the appropriate facilities to house people there for more than 3 months.

The Mt. Royal Inn is not equipped with fire suppression which constitutes a significant danger to life situation. The Mt. Royal Inn is required to have a fire announcement system. The fire announcement

system is consistently down, not working, or tampered with. There have also been issues of improper smoke detectors or smoke detectors that have been tampered with.

Vice-chair Hoyt requested that *Town Counsel, Ed St. John III*, send a letter to Mt. Royal Inn regarding their license.

The motion to table the approval of the Inn Holder's license for the Mt. Royal Inn passes unanimously.

Appointment of Member Nowak to the "Northwestern MA Woodlands Partnership"

There was a motion from Member Blanchard to appoint Member Nowak to the the Northwestern MA Woodlands Partnership. The motion was seconded by Vice-chair Hoyt. 4 members vote to approve with member Nowak abstaining. The motion carries.

Discussion on Select Board Agenda Topics

Member Nowak noted that a number of people have come forward asking for transparency. With the Town Council and the Town Administrator making a salary, it is important for them to provide a report at the Select Board Meetings.

There was a qmotion from Member Nowak to bring back the Town Administrator's Report and Town Council's Report for the purpose of transparency. No second was made. Motion dies.

Chairman Duval stated that when there is an open agenda item such as "Town Administrator's Report" or "Town Council's Report", it does not enumerate what is actually being reported on. Instead, there was a time when any question of any kind would be asked which would lead to confusion and a lack of transparency. For that reason, the Board decided that instead, members can submit topics to be put on the agenda, so that the town is given the information that is needed in order to be kept up to date. A member can submit a topic to the Chair which allows the board and Town Administrator to call in any other staff member that may be necessary in order to appropriately and completely answer the questions that are being raised. If there is something that any member of the board would like to see on the agenda, simply pass it forward and the board can have a good discussion.

SUBCOMMITTEE AND LIAISON REPORTS:

Member Rosenberg: Personnel Subcommittee met on November 28th. There were 4 positions that were discussed. There are department heads that are doing more administrative work. The town is looking to add an Assistant Town Accountant, Assistant Treasurer, Administrative Assistant to the Department of Inspection Services, and Assistant Director of Community Development

Jay Green: By changing the title of the two existing positions (financial assistant in the Accountant's office and Treasurer's office) it allows the two individuals in those roles access to more trainings, more education, and take part of the work at a higher level. The only position that is actually being created is a 19-hour, part time, non-benefited position. The individual who is interested in that role is

already employed in town hall part time and as such, they would assume the two part-time salaries and one benefit load, which we believe to be the most cost effective and creative way. The Personnel committee has asked that we treat this as a study to see if it will make more sense to create a full-time position.

Vice-Chair Hoyt: In addition to the positions that were discussed at the personnel subcommittee, we talked about researching and implementing a code of conduct that applies to town staff, elected officials, volunteer boards, and those who visit Town Hall in order to do business.

Member Nowak wants to know who will be policing the conduct of elected officials. *Member Nowak* feels that that will be forcing elected officials to conform. Our handbook and code of conduct only applies to staff, and a code of conduct would require board members to be accountable to someone, when they should only have to be accountable to their constituents. *Member Nowak* stated that he has not seen a Code of Conduct in any community.

Vice-chair Hoyt stated that she has examples from Lanesborough. There have been issues from across the state that have had surfaced during conversations with other member of the Massachusetts Municipal Association.

Member Nowak stated that he is always bumping his head against the rest of the board. The code of conduct should be dictated by a member being voted out of office, but to have a code of forces people to act a certain way.

Chairman Duval stated that has been a recommendation in the Board of Selectmen handbook in the past regarding conduct.

Member Nowak made accusations against other members of the Board and was deemed out of order by *Chairman Duval*.

Member Nowak Stated that he attended the eagles brass concert at the Library.

ANNOUNCEMENTS AND GOOD OF THE ORDER

Chairman Duval stated that next Wednesday there will be a vote at the meeting to select an agency for the two campgrounds that have responded to the RFPs for Greylock Glen. Additionally, the Santa Parade with Adams Public Safety has been successful in the past. This year it will be at 6pm on Sunday evening, December 18th.

Member Rosenberg: None

Vice-Chair Hoyt: Thank you to ACB for organizing the Adams Holy-days and for all of those who came out even in the mail. Also, thank you to McCann for inviting *Vice-chair Hoyt* to be a liaison to see the Shop Showcase.




Member Nowak: Wanted to know what was happening with culver on Jordan Street. *Jay Green* stated that FEMA funds were secured for it, however the project is still in design phase. FEMA is responsible for providing the money for design as well as the execution of the project. *Member Nowak* also wanted the people at home to say their prayers for the people of Ukraine. There are a number of folks struggling.
