CALL TO ORDER: On the above date, the Board of Selectmen held a meeting at 5:30 PM at the Adams Free Library. Chair Christine Hoyt opened the meeting. Present: Chair Christine Hoyt, Vice-chair Howard Rosenberg, Members John Duval, Richard Blanchard, and Joseph Nowak. Also present were Jay Green, Town Administrator; Crystal Wojcik, Town Finance Director; Bri Hantman, Recording Secretary, and Bill Flynn of the Adams Retirement Board

Application for One Day Liquor License for Adams Turners Inc at 6 Turners Ave from 3pm-7pm on June 3.

Member Blanchard made a motion to approve the one-day license for Adams Turners Inc at 6 Turners Ave from 3pm to 7pm on June 3rd. The motion was seconded by vice-chair Rosenberg. Motion passed unanimously.

Facility Use Request for 57Park Street to close school street.

Member Blanchard made a motion to approve the Facility Use Request for 57Park Street including the road closure of School Street. The motion was seconded by Vice-chair Rosenberg.

Member Blanchard asked if the sally port would still be accessible to the Police Department. It was clarified that yes, the police would still have full access to the sally port and the police station.

The motion passed unanimously.

Public Entertainment License for Lea King at 57Park Street

Member Blanchard made a motion to approve the one Day entertainment License for Lea King for School Street for 2-4 pm on June 10^{th} . Vice-chair Rosenberg seconded the motion. The motion passed unanimously.

Announcements and Good of the Order:

Member Nowak asked if the Crosswalk would be done with permanent paint. Town Administrator Green answered that yes, it is. Member Nowak also asked if there were any bylaws regarding murals. He is worried that the paint will start chipping due to the stucco style

of the building. *Member Nowak* also asked if there has been any movement with the purchase of the diner. *Chairman Hoyt* stated that the date of the closing has been pushed out. *Member Nowak* was pleased to see a great turn out for the Adams Theater on Friday and Saturday night.

Town Administrator Jay Green stated that the Greylock Glen Outdoor center building is an active construction site. No one is to enter the building or cross into the fenced off area without permission

Vice-chair Rosenberg asked for clarification for where the public is allowed to go with regards to the outdoor center building. *Town Administrator Green* stated that nobody should be crossing the fence line. There have been significant issues with break-ins and theft. It is an active construction zone. The police have placed cameras at the site.

Member Duval asked if the police department was able to determine when the equipment went missing or who the individuals were. Town Administrator Green stated that the individuals were not able to be identified.

Member Nowak stated that he wishes that there are cameras at Oak Turn because there are over 300-400 tires dumped in the area. Vice-chair Rosenberg offered to go up with member *Nowak* to look at the property.

Chairman Hoyt stated that next Wednesday, June 7th is town Meeting. The next Board of Selectmen Meeting will be Wednesday, June 21st.

Member Blanchard made a motion to adjourn. The motion was seconded by Vice-chair Rosenberg. The meeting adjourned at 5:48pm.
