### **MINUTES**

### ADMINISTRATORS REPORT

- 1. Through the Adams historical Society the Town recently received a \$1000 donation from Edward and Allison Wells of Portola Valley, California. The Wells are decedents of one of the first families to settle in Adams. The \$1000 donation was designated to be used specifically for the care and upkeep of the Quaker Meeting House. The Adams Historical Society Board of Directors voted at a recent meeting to transfer this donation into the Town's funds for the preservation of the Quaker Meeting House.
- 2. Town's Landfill Solar Project Tecta Solar is beginning final testing of the 1.1 megawatt solar facility next week. The site is expected to be operational and bringing the Town significant savings in the form of discounted electricity likely within the next few weeks.
- 3. The Mount Greylock Ramble and Ramblefest festival were both daunting successes over the Columbus day Weekend. The Town played a role in helping facilitate these events that were the work of the Adams Events Committee and ProAdams. Other organizations that participated included the Historical Society, Youth Center, Inc. and the Thunderbolt

Ski Runners. It was truly a collaborative weekend in our community, which saw thousands of visitors fill our streets.

#### TOWN COUNSELORS REPORT

The following work was performed since my last report:

- Continued communication with legal counsel for Bay State Elevator regarding inspection issues, receipt of decision re fine (which Bay State will pay) and communication with Town Administrator concerning status.
- Continued investigation of status of Gould Road as a public way.
- Meeting with Town officials regarding Planning Board decision, rejecting site plan approval for solar array project, and research applicable law in preparation for appeal.
- Review and edit contract for Police Chief.
