August 21, 2013

On the above date the Board of Selectmen held a meeting at Town Hall at 7:00 PM. Chairman Duval presided, present were Michael Ouellette, Arthur Harrington, Joseph Nowak, Richard Blanchard, Jonathan Butler, Town Administrator and Edmund R. St. John III, Town Counsel.

Chairman Duval called the meeting to order at 7:00 PM

READING OF THE MINUTES

A motion made by Member Ouellette, seconded by Member Harrington to approve and waive the reading of the minutes from May 22nd and June 5th & 12th - Unanimous motion passed.

A motion made by Member Ouellette, seconded by Member Blanchard to approve and waive the reading of the minutes from June 13th - 4 Yeas, 1 Abstained (JD) - motion passed.

A motion made by Member Ouellette, seconded by Member Blanchard to approve and waive the reading of the minutes from July 24th – 4 Yeas, 1 abstained (AH) motion passed.

CITIZENS CONFERENCE

Barbara Meczywor speaking for the Parks Commission asked the Board if the Students at McCann's High school could fabricate the extension of the railings on the bleachers located at Renfrew to help save money. Jonathan Butler, Town Administrator commented that McCann's is an option or if it's a reasonable cost, something under \$1500 we could possibly absorb it in the operating budget. Otherwise there is no capital money for this, unless the Finance Committee wants to appropriate it out of the reserve fund. Member Ouellette asked Ms. Meczywor if this is such a safety concern, why wasn't it not voted to be on the priority list from the Parks Commission Ms. Meczywor replied that she didn't think they took a vote on the list, she thinks because the soccer field needed to be done that was the focus.

OLD BUSINESS

There was discussion by each Board Member as to who they chose for the Police Chief position.

A motion made by Member Ouellette, seconded by Member Blanchard to appoint Sean Hegeany to the position of Police Chief for the Town of Adams - 2 Yeas 3 Nays (JD, JN, & AH) motion failed.

A motion made by Member Nowak, seconded by Member Harrington to appoint Richard Tarsa Jr. to the position of Police Chief for the Town of Adams – 3 Yeas 2 Nays (MO & RB) motion passed.

A motion made by member Nowak, seconded by Member Blanchard to approve the request for the Artie & Abby Benefit to be held on Saturday, September 21, 2013 – Unanimous

NEW BUSINESS

Carol Cain updated the Board regarding the Visitors Center, this year they have added hours, they are averaging 60 - 62 hours they are open a week, 7 days a week. It has been a consistent staff and people coming through the Center have increased every month.

Erica Girgenti, Council on Aging Director also updated the Board on events at the COA. Member Blanchard asked if there was a lot of out of Town participants, yes there are some out of Town but the majorities are Adams residents.

TOWN COUNSELOR'S REPORT

The following work was performed since my last report:

- Review materials submitted by building Inspector's office regarding plan of subdivision and communication with applicant's counsel.
- Continued communication with the Department of Revenue legal staff regarding legality of funding school nurse's position at St. Stanislaus Elementary School.
- Communications with Bay State Elevator regarding inspection issues.
- Respond to inquiry concerning quorum issues.
- Investigate status of Gould Road as a public way.
- Respond to Board request relating to disposition of non-criminal violations of bylaws.

Member Nowak responded to the letter received from Time Warner Cable and announced that they will attend a Board of Selectmen's meeting on September 4, 2013 to address the concerns residents have regarding their cable. He also commented on the Tag Sale signs around Town and asked people to remove them when their tag sale is over.
