On the above date the Board of Selectmen held a meeting at Town Hall at 7:00 PM. Chairman Duval presided, present were Michael Ouellette, Arthur Harrington, Richard Blanchard, Joseph Nowak, Jonathan Butler, Town Administrator and Edmund R. St. John III, Town Counsel.

Chairman Duval called the meeting to order at 7:00 PM

READING OF THE MINUTES

A motion made by Member Ouellette, seconded by Member Harrington to waive the reading and approve the minutes of April 3, 2013 – 3 Yeas, 2 Abstained (RB & JN) motion passed

CITIZENS CONFERENCE

Resident, Jeff Lefebvre asked the Board to look into putting picnic tables outside in the Armory Court for residents to enjoy eating outside. Jeff also asked when WILCO returns to Mass Moca if someone could talk to the Department of Conservation and ask if people could camp at the Greylock Glen during this event. Member Harrington stated that this was DCR regulated and the organizers for Mass Moca should be the ones who contact with DCR. Jeff also asked about the solar project being built on Spring Road, Chairman Duval commented that at this time that project was in the hands of the Planning Board, then to Conservation.

There was discussion by the Board regarding the Department of Conservation request. DCR asked the Board for their approval of the "Friendly Taking" for the Departments use of eminent domain under provisions of Gen. Laws ch. 132A, §3 .- of 269 acres – Fritz property and 9 acres – Burke property.

A motion made by Member Harrington, seconded by Member Ouellette to approve the exercise of the power of eminent domain by the Commissioner of the Department of Conservation and Recreation, acting pursuant to and in accordance with Section 3 and 3A of Chapter 132A of the General Laws, to acquire 294.0 acres, more or less, located in the Town of Adams. This vote is expressly conditioned upon the payment to the Town of Adams of all outstanding real estate taxes on the subject property – Unanimous motion passed.

A motion made by Member Ouellette, seconded by Member Harrington to approve the exercise of the power of eminent domain by the Commissioner of the Department of Conservation and

Recreation, acting pursuant to and in accordance with Sections 3 and 3A of Chapter 132A of the General Laws, to acquire 9 acres, more or less, located in the Town of Adams – Unanimous motion passed.

A motion made by Member Ouellette, seconded by Member Blanchard to deny the request to allow dogs in the cemeteries - Unanimous motion passed

Chairman Duval informed the Board of Selectmen of their Sub-Committee assignments, he stated that this is a living document and if necessary it can be updated and changes made to it.
