On the above date the Board of Selectmen held a t meeting at Town Hall at 7:00 PM. Chairman Duval presided, present: Michael Ouellette, Arthur Harrington, Richard Blanchard, Joseph Nowak, Jonathan Butler, Town Administrator and Edmund R. St. John III, Town Counsel.

Chairman Duval called the meeting to order at 7:00 PM

#### **CITIZENS CONFERENCE**

Resident, Jeff Lefebvre announced that the Maple Grove Civic Club will be holding their last meeting for before the summer breaks on Sunday at the PNA – William Kolis will be the speaker. Jeff also wanted to express special thanks Daniel Pitoreck for all the community donations he makes throughout the year. He is very supportive and generous with all the community events held throughout the year. Jeff is also is asking for donations for Soldier On they are in need of personal items: toiletries, flip flops or sandals, bedding: sheets pillow cases, blankets. Jeff will have a box located at Town Hall for residents to drop off donations.

Residents, Edward Driscoll and Dave Kaminski spoke to the Board, representing the residents of the north end East Road. They are concerned about a possible solar powered generating facility; they asked about an overlay for large scale ground mounted solar units they would support that. They asked if there could be a moratorium on permits so there wouldn't be a land rush in the time between now and the approval of a bylaw. Chairman Duval stated that the Board of Selectmen has not taken up that subject but he does believe that it is needed.





This is in response to a Board request that derived from the Spring budget meetings and the Town's proposed changes to how we fund our inspection services.
- 2. Berkshire Regional Planning Commission has been awarded \$400,000 in funding under an **EPA Brownfields Grant**. This funding will assist in assessing properties potentially contaminated by petroleum or by hazardous materials. The Town's Community Development Director is a member of the Berkshire Brownfields Committee and the grant funds distributed by the Committee have assisted several property owners in Adams with their assessment needs, and have helped move certain Town projects to be ready for development. Properties likely to be assisted in this next round include one or two properties along Commercial Street and the Memorial School.
- 3. The Community Development Director and the Building Inspector met with the chairs of the Planning Board and the Zoning Board to discuss future **Zoning Bylaw changes** and agree on priority needs. The Community Development Department will have a recommendation to the Selectmen on needed Bylaw amendments and workshop meetings with the two boards will be scheduled in the next couple of months.
- 4. Austin Design, Inc., the Town's architectural consultant, has now completed its assessment of the **Adams Free Library building** and identified renovation priorities for the building. The Architect's findings will be presented to the project Steering Committee early in June when all Committee members are available to meet.
