CITIZENS CONFERENCE

- 1. The Chief of Police asked that I pass along a few updates and suggestions to the general public regarding the recent car break-ins throughout Town. The Police have been actively investigating this and exploring several leads. However, it is important that people are aware of the risks in leaving your car unlocked. Adams, like any other community, is susceptible to theft if the circumstances for theft exist. Many of these break-ins were to vehicles that had been left parked over night without being secured. People are encouraged to lock their vehicles at night and to activate their vehicles security systems if they have them.
- 2. Last week, Member Duval and I attended a meeting at the Community Center to meet with the Board of the Directors for Youth Center, INC. We plan to continue to keep an open line of communication with them, and assist in any way possible as they work towards a transition out of the East Street facility.
- 3. We have also been in contact with Sandy Totter from the Northern Berkshire Solid Waste Management District (NBSWMD). They have a small office space at the Community Center which acts as the headquarters for management of their operation. Sandy appears to be very pleased at the notion of moving into a more central, downtown location. We have been investigating potential options, but have a lot of interest in the Registry of Deeds space on Park Street. For some time, the Registry has been alone in that space, with several vacant rooms since Town Hall moved across the street. We've also discussed Town Hall and the Visitor's Center as potential sites.

I have continued to work with the property owners, the town and the state concerning the easement documents for proposed Rail Trail. This has included telephone conversations with attorneys for the abutters and the DOT representatives.

I reviewed bids submitted concerning the demolition of the Albert's Hardware site, contacted the Attorney General's office regarding the propriety of the bidding process and conferred with town staff concerning the bids. I have also spoken with the property owner's attorney regarding language of the proposed agreement.

I am working with Berkshire Gas to provide a site for the materials dredged from the Hoosac River and Tophet Brook.

I responded to a public record request submitted to the police department by a private citizen and conferred with the chief concerning the response.
