CALL TO ORDER: On the above date, the Board of Selectmen held a meeting at 6:00 PM at the Adams Town Hall. Board Chair Christine Hoyt opened the meeting. Present: Chairman Christine Hoyt, Vice-Chairman Howard Rosenberg and Members Rick Blanchard, John Duval, and Joe Nowak were present. Attorney Edmund St. John III was absent. Also present were Jay Green, Town Administrator; Bri Hantman, Recording Secretary; Haley Meczywor, Town Clerk; Jacob Tarjick; Scott Kelley, Chief of Adams Police Department.

The Pledge of Allegiance was recited.

APPROVAL OF MINUTES:

The November 15th, 2023 Meeting Minutes were submitted for approval.

Member Blanchard made a motion to accept the November 15th, 2023 Meeting Minutes as presented and waive the reading. Vice-chair Rosenberg seconded the motion. The motion passed unanimously.

NEW BUSINESS:

Ratification of Jacob Tarjick as Program Manager in the Community Development Department

Town Administrator Jay Green offered an overview of the Program Manager position in the Community Development Department. Town Administrator Green read the ratification memo that was prepared.

Member Blanchard made a motion to ratify the appointment of Jacob Tarjick to the position of Program Manager in the Community Development Department at the Grade 12 Step 1 rate of \$60, 448 annually. The motion was seconded by Vice-Chair Rosenberg. The motion passed unanimously.

Review and Approve Dog License Fee Proposal

This item was supposed to be the Dog Kennel License Fee Proposal. As such, this item will be listed correctly and then taken up at the December 20th meeting. No action was taken by the board.

Adams Police Department Grant Update

Chief Scott Kelley approached the Board of Selectmen. Some of the trainings and education programs that have already happened this year have been mental health, firearms, first aid, and various other trainings. Those are just standard and regulatory trainings.

Mr. Cole Deroches is still in the academy. Chief Kelley has received updates stating that he is doing well. He is still on track to graduate in April which will bring the department up to full staff. The police department has a new Chevy Tahoe, and they are enjoying that vehicle. With all that stated, Chief Kelley wanted to tell the board about a several grants that they have received recently.

With that, the APD has received just short of \$160,000, with two more grants still pending. The grants received have included a Victim's Advocate Grant for \$12,000, a Child Safety Grant for \$4500, a Traffic Safety Grant for \$24,000, a grant for Body Worn Cameras for \$110,000, and an additional grant for \$9,000 that helps the investigators do their work.

Member Nowak asked Chief Kelley to place an officer at the crosswalk by Notre dame Church during the winter months when it is dark out at the time when Church gets out. Chief Kelley stated that it would be a great idea and certainly possible due to the Traffic Safety Grant.

Vice-chair Rosenberg as for some clarification on what the Victim's Advocate does. Chief Kelley stated that victim's advocates, in partnership with the Elizabeth Freeman Center, will reach out to a victim if they meet certain criteria. The grant helps cover some of the overtime that may be incurred by Victim's advocate. It also pays for additional funding for the Elizabeth Freeman Center to help support victims.

Member Duval asked if there is any grant that provides for a program to do traffic stops during the holiday season or during months that there is excessive speeding. Chief Kelley clarified that that is part of the Traffic Safety grant.

Request to Allocate Space at Bellevue Cemetery for K9 Memorial and Resting Place

Chief Kelley stated that the Board has received an email and were notified that the Town of Adams' first K9, Kumar, had to be put down this week. Sergeant Crane is doing okay, but Kumar was certainly more than a work partner for Curtis. Chief Kelley stated that in the south, it is more common to have memorials for K9 officers.

The idea is to honor, not only K9s in Adams, but in other jurisdictions who may not have the space or the availability to honor K9s. There is a spot where everyone parks to go down to the falls at Bellevue. That land is not ever designated to be sold as plots for the cemetery. In the curve of the land, there is a space that is never going to be sold as a plot, that Chief Kelley would like to see a Memorial with the names and years of service of police K9s. Typically K9 handlers take home the ashes of the K9 partners. Several handlers would like to see a portion of the cremains to be places in the memorial.

Town Administrator Green stated that Commissioner Shepley of the Cemetery Commission took a poll of the commissioners and they agreed that this would be an ideal spot. Because it is not a burial plot, there is no cost. Additionally, because the remains are cremated, there are no regulations regarding burial of an animal.

Member Nowak asked if any other community has a burial place for animals. Chief Kelley stated that no other community has one. Adams would be the first. There is a memorial in Pittsfield, but it is not a resting place.

Chairman Hoyt stated that it is a very special group that handles dogs. Chairman Hoyt stated that prior Town Administrators Mazzucco and Butler offer their condolences.

Member Duval stated Kumar was not only a great asset for the police force, but for the community.

Member Blanchard asked if the memorial space would be limited to police dogs, or if it would be open to other public safety K9s. Chief Kelley stated that it would be limited to police dogs.

Member Blanched made a motion that the board approve the request to allocate space at Bellevue Cemetery for K9 resting place. Seconded by member Duval.

Member Duval requested an amendment to the motion be made to add that the oversight and management of the burial space be the purview of the Town Administrator and Chief of Police. *Member Blanchard amended his motion to include this, Member Duval amended his second. The motion passed unanimously.*
