Town Counsel Report: There was no report submitted by Town Counsel.

SUBCOMMITTEE AND LIAISON REPORTS: Chairman Duval advised there will be a Berkshire Regional Planning Commission Executive Meeting tomorrow, and the regular meeting will happen later in July. Member Nowak advised that he attended the Parks Commission Meeting on Monday and scheduling for the Youth Football League and night games to be played by the high school and Women's Soccer were discussed. He reported that there is a concern about Russell Field's poor conditions of the infield and backstop and there is a question about how long it is taking for the grant to come through to correct deficiencies in the field. He also announced that the Women's Softball Team won seven to zero in their tournament, and congratulated them. Member Nowak reported that he attended the Zoning Board of Appeals meeting and the Zoning Board Members are pleased with the latest additions of Francie Riley, Glen Diehl and Jacob Levesque to the Board. ZBA discussion took place regarding the Solar Field on the gravel pit and changes on zoning to allow a portion for gravel pit use and majority of the property to be used by a solar company from New Hampshire. A request was made to have the grant status for Russell Field to be a future agenda item. Member Bush advised that he attended a meeting with Berkshire Sheriff's 911.

ANNOUNCEMENTS AND GOOD OF THE ORDER: Member Nowak advised that he noticed the solar array at the Town Landfill is overgrown and weeds are growing over the panels, impeding the panels from the sun and becoming unsightly. He expressed that the Town needs to take a look at Park Street because the pavement is breaking up and before there are more problems he requests the DPW look at sealing up the cracks before winter. He praised the Adams Community Bank for looking into the issue with the clock. He explained that it is difficult to find people to maintain these types of clocks and they are looking for a company to rectify the problem. For the time being they have removed the hands of the clock.
