Proposed Motion to clarify Board's Oct. 11, 2022 vote: *The Mohawk Trail Woodlands Partnership (MTWP) voted at its 11 October 2022 Board Meeting to change its operational name to The Woodlands Partnership of Northwest Massachusetts, and to request our State Legislators, the Massachusetts Executive Office of Energy and Environmental Affairs, and the USDA Forest Service to take necessary actions to make the new name the official, legal name of the Woodlands Partnership.*

Below is the text of the Oct. 11, 2022 Board motion approved unanimously:

"The Mohawk Trail Woodlands Partnership", a public body established by Massachusetts House Bill No. 4835 filed on 26 July 2018 and signed into law on 31 October 2018, will conduct its work known as "Woodlands Partnership of Northwest Massachusetts," and change its bylaws to reflect said change in name. ...

We furthermore request that the legislature of the Commonwealth of Massachusetts and the U.S Department of Agriculture - U.S. Forest Service officially establish and recognize the name of the public body formerly known as "The Mohawk Trail Woodlands Partnership" as being henceforth "Woodlands Partnership of Northwest Massachusetts."
