The Mayor of North Adams as the Cable Television License Issuing Authority for the City of North Adams and the Board of Selectmen/Select Boards of the Towns of Adams, Cheshire, and Clarksburg or the respective representatives of said Towns on behalf of said Cable Television License Issuing Authority, will hold a public ascertainment hearing regarding the Renewal Cable License of the respective cable television licenses of Spectrum/Charter Communications on Wednesday, April 24, 2024 at 6:00 P.M. at the North Adams City Hall (Council Chambers), 10 Main Street, North Adams, MA, with an option for remote video attendance and participation (in-person participation is encouraged). Information for attending and/or participating remotely will be listed on the respective City and Town websites and may be obtained from the respective offices listed below.

All North Adams, Adams, Cheshire, and Clarksburg residents and persons associated with an organization or business so located are encouraged to attend and participate in the hearing. The purpose of the hearings is to:

- (a) Identify future cable-related community needs and interests, and
- (b) Review the performance of the cable operator under its current Cable License.

The hearing is being held according to the Massachusetts Cable Law (M.G.L. c. 166A, sec. 13) and the regulations of the Massachusetts Dept. of Telecommunications and Cable (207 C.M.R 3.05) and any applicable laws, regulations, or requirements regarding the renewal of the respective cable television license.

Applications, reports, statements, and/or amendments, if any, will be available for review, download, and/or reproduction from the Office of the Mayor in the City of North Adams and the respective Town Administrator's Office in the Towns of Adams, Cheshire, and Clarksburg.
