GREYLOCK GLEN WATER SYSTEM IMPROVEMENTS PROJECT

The work consists of the construction of an elevated water storage tank, approximately 1,200 LF of water main, water storage tank site improvements, overhead and underground electrical service, water tank process piping, electrical and instrumentation systems, concrete backflow preventer vault, pump station modifications (including installation of a hydropneumatic tank), construction of an above-grade heated enclosure with flow meter and related piping, replacement of pump motors and seals, installation of a PLC pump control panel, 4-inch water main, and restoration of all disturbed areas.

Bids are subject to MGL c. 30 §§39M and to the minimum wage rates per MGL c. 149 §§26 to 27H, inclusive and Federal Labor Standard Provisions 29 CFR 5.5. The schedules of wage rates are included in the bid documents. A bid bond or certified check in the amount of five percent (5%) of the bid must accompany the General Bid. Bidders must use the approved bid form and mark: "ADAMS BID #23-005: GREYLOCK GLEN WATER SYSTEM IMPROVEMENTS" on the outside of the sealed envelope.

Bidders are encouraged to meet the Disadvantaged Business Enterprise (DBE) goals for this project. The goals for this project are 4.2% D/MBE participation and 4.5% D/WBE participation. Percentages are applicable to total dollars paid to the construction project.

The project is subject to Requirements for Affirmative Action to Ensure Equal Employment Opportunity (Executive Order 11246 and 41 CFR Part 60-4).
